

# Shareholder Communication Policy

## Clough Limited (“Company”)

The purpose of the Clough Shareholder Communications Policy is to ensure that effective communication with shareholders is promoted and maintained and to encourage participation at annual general meetings.

The Shareholder Communications Policy has been established in support of the ASX Corporate Governance Council’s Principles of Good Corporate Governance and Best Practice Recommendations.

The Board aims to ensure that shareholders are informed of all major developments affecting the Company. All shareholders have access to both the Company’s annual report and half-year reports. These reports are available online via the Company website at [www.clough.com.au](http://www.clough.com.au) or in hardcopy by request via the Company’s Share Registry. The Company also encourages full participation of shareholders at the annual general meeting of the Company.

Shareholders have a choice with regards to the method in which they receive notices of meeting and may elect (by written notice to the Company) to receive such notices of meeting by either post, facsimile or electronically. Shareholders who are unable to attend meetings of the Company are encouraged to participate in meetings by way of appointment of a proxy. Proxy forms may be lodged by shareholders by way of post, facsimile or transmission to the electronic address specified in the relevant notice of meeting.
